Article 2.2 Objectives	Added a new section titled "2.2 Objectives"	The Board wanted to add additional detail as to what are the objectives of the Association
Article 3.2 Terms	Officers and Chairmen shall serve no more than two consecutive terms in the same role, after which they must either 1) run for another position on the board, or 2) step down from the Board for at least two years before being eligible for re-election.	To ensure we the Board is bringing "new blood" into the board, we added "term limits" to each position. The Board wants to encourage all members to be active in the association and bring new ideas to it.
Article 3.3 Elections	Added a section on elections clarifying when they occur and adding an obligation on the Secretary to convene a Nominating Committee for nominating Candidates for the Board prior to the election.	To facilitate bringing new Board members into the Board, we wanted to create a nominating committee whose job it is to create a slate of qualified members for each position.
Article 3.4 Vacancy	Clarified the board's options on filling Board vacations and clarified that regardless of term, any vacations for the board will be on the next election cycle	Clarified wording of filling positions during the year.
Article 3.6 Powers	Clarified that any expenditures of association monies not directly attributable to association expenses require membership approval or 3/4 of the board's approval.	The Board wanted to ensure all expenditures outside of normal business have proper approval.
Article 4.2 President	Updated the Presidents responsibilities and moved the audit clause to the Treasurer responsibilities. Added marketing responsibilities and the ability to create new committees not defined in the bylaws	Changes intended to clarify the President's responsibilities. Audit responsibilities moved to regular review of Treasurer's reports to simplify audit and to ensure membership has ability to review association finances at any time.
Article 4.3 Tournament Director	Updated the Tournament Directors responsibilities. Removed Vice President from the role	Changes intended to clarify Tournament Director's responsibilities. In addition, the Board felt there is no need for a Vice President role.

Article 4.4 Secretary	Updated the Secretaries responsibilities. Moved Membership Director responsibilities to Membership Chairman	Changes intended to clarify Secretary's responsibilities. Added responsibilities for association newsletter and nominating committee. Moved membership responsibilities to clarified "Membership Director" role.
Article 4.5 Treasurer	Updated Treasurer responsibilities. Modified to recognize the use of electronic payments versus checks. Replaced section (moved from President responsibilities) for an annual audit and modified it to require board approval of monthly finances and annual budget, with added section for both being available to membership upon request.	Changes intended to clarify Treasurer's responsibilities. Disbursement of funds need to be updated to recognize use of electronic payments. Added section on providing approval and visibility of finances to the board, and to membership to simplify annual audit requirements.
Article 5.2 Handicap Chairman	Updated Handicap Chairman adding further detail on the role	Changes intended to clarify Handicap Chairman's responsibilities.
Article 5.3 Rules Chairman	Updated Rules Chairman role, adding further detail on the role.	Changes intended to clarify Rules Chairman's responsibilities.
Article 5.4 Operations Chairman	Updated Operations Chairman role. Role is now primarily responsible for the managing the association's website and for any special events the association decides to sponsor.	The Board needed someone to take responsibility for managing the associations website and any special events. Given the Operations Chairman had limited responsibilities previously, and mainly supported the Tournament Direction, the Board recommends modifying this role to the responsibilities listed.
	Eliminated Meeting Night Chairman role and merged key responsibilities into Operations Chairman role	The association has not had a Meeting Night Chairman for many years. The Board recommends eliminating this role and merging the responsibilities with the Operations Chairman.
	Eliminated Event/Invitational Chairman role and merged the responsibilities into the Operations Chairman role	The association has not had a Event/Invitational Chairman for many years. The Board recommends eliminating this role and merging the responsibilities with the Operations Chairman.
	Added responsibility for managing the Associations website to the Operations Chairman role	See above.

	Removed responsibilities related to golf course management and tournament operations (integrated into Tournament Director role)	See above.
Article 5.5 Membership Chairman	Created new role of Membership Chairman. Moved previous responsibilities of the Membership Director to this role. Added onboarding new members and annual survey responsibilities to the role. Manages Association membership roster, onboarding of new members, and annual membership survey	The previous role of Membership Operations Chairman was ill defined. The Board recommends modified this role to consolidate the membership responsibilities previously assigned to the Secretary and to add the focus on the onboarding new members and representing current members in Board meetings.
Article 6.1 Qualifications of Membership	Changed the requirement of members to be male to person	The Board recommends removing the requirement that members be male and to allow women to be part of the association. The previous board approved having two women participate in the association for numerous reasons and the current Board agrees this is of value to the association.
Article 6.2 Expulsion/Discipline of Members	Added additional detail to the process of disciplining, disqualifying, suspending or expel members from the association	The previous bylaws did not sufficiently describe the process (and appeal process) for disciplining/disqualifying/suspending/expelling members for poor behavior. The reworded section adds clarity to these processes.
Article 7.1 Annual Meeting	Clarified the purpose of the annual meeting	The Board wished to clarify and update the purpose of the annual meeting.
Article 7.2 Board Meetings	Clarified Board meeting requirement to be official and Board decisions to be approved	The previous bylaws were unclear on the quorum required for membership and board meeting decisions. The Board has tried to clarify the number/percentage of membership/board members required for bylaw changes and board decision.

Article 9.1 Amendment to the Bylaws	Added detail on the approval process for Bylaw changes and Amendments to be proposed by membership and Board members, and the required approval percentages	The previous bylaws were unclear on the quorum required for membership and board meeting decisions. The Board has tried to clarify the number/percentage of membership/board members required for bylaw changes and board decision.
